



Club Rose Bay x Coopers Pool Competition 2026 (Promotion) – Conditions of Entry

1. Information and instructions on how to enter, the mechanics of participating in the Promotion and prizes form part of these Conditions of Entry. Participation in the Promotion is deemed acceptance of these Conditions of Entry. The promoter of the Promotion is Hemmes Trading Pty Ltd ABN 29 105 332 652 trading as Merivale of 320 George Street, Sydney NSW 2000 (Promoter).
2. Participation in the Promotion is only open to current Club Rose Bay members aged 18 years or over. Directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies directly associated with the Promotion are ineligible to participate. If a winner is discovered to be under the age of 18 years, they will automatically be disqualified.

 - Register for the Coopers Pool Competition with the event host; and
 - Participate in the weekly pool competition.
5. Weekly competitions will be held every Tuesday at Club Rose Bay from 16 June 2026. The winning team from each weekly competition will:
 - a. Receive two (2) \$250 Visa Gift Cards; and
 - b. Qualify for the Grand Finale.
6. The Grand Finale will be held at Club Rose Bay on a date determined by the Promoter. The winner of the Grand Finale (Winner) will receive the Major Prize outlined in Clause 8.

WINNER DETERMINATION

7. The Winner will be determined by performance in the Grand Finale pool competition. This is a game of skill and chance plays no part in determining the Winner. The Promoter's decision is final and no correspondence will be entered into.
